Executive Director's Report



Over the past 27 years, the Board of Directors, staff, volunteers, clients, funders and other stakeholders of North Okanagan Hospice Society put the building

blocks in place to create a strong foundation for Hospice. Our team continues to build on this foundation to ensure that hospice palliative care is available to all residents of the North Okanagan.

This year, we provided service to 185 residents and their loved ones at Hospice House. We also provided bereavement follow-up and community counselling support for those who experienced either an expected death or the sudden death of a loved one. As well, volunteers continued to provide companionship and practical support to palliative clients in the community. In total, Hospice provided direct and indirect support to 1,320 residents of the North Okanagan in 2010-2011.

The demand for our services remains strong. We are confident that we are delivering a service that is greatly needed and much appreciated when we receive thoughtful expressions of gratitude from our clients and their loved ones. The following words illustrate that appreciation:

a Few Words from Angela, a volunteer

I have volunteered at Hospice since October, I work every Thursday and every other Saturday. I will tell you what I do as a volunteer:

I arrive usually about 4:30. There is a cook full time so I don't have to cook (good thing). She makes the meal and keeps it in a warmer. I go and say hello to each of the residents and introduce myself to those I haven't met. I like to touch base with them about supper and I find out how they are feeling and what they would like to eat. Often, they will ask for whatever meal has been prepared, but sometimes they want just ice cream for supper, or soup, or something wild and crazy. So then I go and prepare their meals and get the trays ready. Hospice has 12 residents but usually they don't all eat. Some people will need help eating, if they don't have the coordination or the strength to do it themselves. I usually say "Can I join you for dinner?"

After the meal is done, I do the dishes and then have time to visit. I will work on a puzzle with someone or just sit and hold their hand. It has its emotional times, I am a bit of a softie and it is hard to see people suffer. But, you just be strong and confident knowing you are making a difference. I have sat with more than one person when they take their last breath, no one should be alone when they die, so I will sit with them and talk to them or sing to them even if I don't know if they can hear me. It is an experience that is indescribable.





A Few Words from Tammy, RN

What motivates you to be so committed to your work at Hospice?

I feel more effective as a nurse giving holistic care. Working here has restored my faith in nursing and humanity. I recognize palliative end-of-life care as a specialty area which is honoured and focused on here, therefore giving me a greater sense of accomplishment professionally. It is an honour and privilege to journey this path with our clients.
