It has been my privilege and honour to serve this past year as President of the North Okanagan Hospice Society. The Board of NOHS is a very dedicated group of volunteers who are committed to not only Hospice House itself but to serving the community as a whole and supporting the provision of End-of-Life Care for those individuals and families who live in the North

Okanagan.

The Board is comprised of nine individuals who come from many different walks of life, but have one common denominator, support for quality end-of-life care in the North Okanagan.

This past year the Board has continued its focus on connecting with residents of the North Okanagan through its Ownership Linkage Committee. The residents of the North Okanagan are the "owners" of North Okanagan Hospice Society. One of the most important duties of the NOHS Board of Directors is to connect with our owners, and learn as much as possible from them about their views related to end-of-life care. The Ownership Linkage Committee of the Board is responsible for making this connection with owners and then reporting their findings back to the Board. What the Ownership Linkage Committee learns from our owners greatly assists the Board in planning the future direction for North Okanagan Hospice Society.

In 2012/13, the Board of Directors' Ownership Linkage Committee surveyed volunteers and also met with North Okanagan residents between the ages of 40-60 to gather their input on the following topics: end-of-life services currently available in the North Okanagan; areas for future program development at Hospice; and knowledge about Advance Care Planning. In addition, the Ownership Linkage Committee met with Interior Health Authority and First Nations organizations to gather their input.

In addition, to their work through the Ownership Linkage Committee, the Board continues with the Executive Director, Ruth Edwards to support staff and volunteers as they provide quality end-of-life care and grief and bereavement support to many individuals and families in our community. Our staff and volunteers are a very dedicated group and it is through their hard work and commitment that NOHS continues to be such an essential service for residents in the North Okanagan.

I continue to be amazed and thankful for the incredible support the community gives to NOHS. It is through this support that NOHS can continue to offer the services we do in support of all residents of the North Okanagan.

Leadership Team Message

Children's Grief Counselling Potential

As part of our 2012/13 Strategic Plan, we investigated whether there was a need for increased grief counselling services for children in the North Okanagan. From January – March 2013, our grief counsellor and a social work practicum student conducted an environmental scan in our community to determine if adequate, affordable



children's grief counselling services were available.

Our environmental scan determined that while there are some resources currently available to address children's grief in the North Okanagan, the accessibility and cost varies. We will continue to monitor the availability of children's grief counselling services. Caregiver Support Potential

NOHS's grief counsellor is currently conducting an environmental scan caregiver support programs across BC for those who are caring for palliative individuals. The goal of the environmental scan is to better understand the types of programs that are currently being delivered in other communities. This information will assist us as we decide on the potential for development of a comprehensive caregiver support program here in the North Okanagan – one which will address physical needs including home care and symptom management; emotional and psychological needs including stress management; social and information needs; and spiritual needs.

Enhanced Communication
