







Executive Director's Report



Our goal each year is to meet or exceed the expectations of the residents of the North Okanagan. Hospices are said to have both a "soft front and a

strong back" and that one cannot exist without the other. Our "soft front" of care, empathy and compassion are provided against the backdrop of our "strong back" of solid organizational policies. It is our daily attention to both aspects of Hospice that ensure excellence in the delivery of our services.

The challenge faced by NOHS this year was Medical Assistance in Dying. Interior Health Authority has not mandated that Medical Assistance in Dying be conducted at our Hospice House, and for this we are thankful. Medical Assistance in Dying is a sensitive and polarizing issue with many layers of complexity. NOHS conducted a comprehensive review of Medical Assistance in Dying to better understand how it might impact our work. NOHS surveyed staff and volunteers for their thoughts on Medical Assistance in Dying. Healthcare professionals from around the province, with decades of palliative care experience, were interviewed to garner their broad range of insight on the issue. We examined many areas of risk and uncertainty. NOHS confirms that our staff will continue to provide quality palliative care for all residents at Hospice House. If some of our residents wish to access Medical Assistance in Dying, we will support them in that decision, we will assist them in obtaining the required assessments and then transfer them to another location to have the procedure completed.

Our operational goal of increasing occupancy at Hospice House to 90% proved to be difficult. There were many systemic barriers to overcome, but with diligence and consistent communication with our partners at Interior Health, we were able to resolve logistical challenges. For the last reporting period of 2017/18 and the first reporting period of 2018/19, we were encouraged to see that our occupancy rate had increased once again to 89%.

We welcome new staff and volunteers to Hospice and wish our former colleagues all the best in their retirement or new ventures. We are confident, that wherever they go, a part of Hospice goes with them and that they will continue to advocate for quality end-of-life care in our community.

Our nurses, care aides, social worker, counsellor, housekeepers, cooks, maintenance staff, administrative staff and management demonstrate cooperative teamwork every day. Their dedication and

generous spirit are evident as they support our clients at end-of-life.

Our volunteers are truly amazing in their capacity to give their time and talent in service to those who are at end-of-life. These wonderful individuals are involved in every program and service that is offered by Hospice – we wouldn't be the same without them!

Province of BC funding (through Interior Health) provides our core funding. We are grateful for this major source of revenue and our cooperative partnership. We regret to inform you that our funding through BC Gaming was reduced this year, but we are thankful for the funding that we continue to receive. We are so grateful for our donors and community supporters who come forward year after year to offer their support through volunteerism, sponsorship and donations.

On behalf of the management, staff and volunteers at Hospice, thank you for your continued support of our work in providing respect, comfort and compassion in life's final journey.

President's Report



The Board of Directors is pleased to report to members of the Society that, once again, the quality end-of-life care services and programs provided to residents of the North Okanagan are provided with the excellence we are noted for.

This achievement can only be met by the caring, professional, and dedicated staff and volunteers and the leadership of Ruth Edwards, Executive Director and her Leadership Team.

Each year brings new challenges to the Society and this year did not disappoint. In particular the Board of Directors recognizes the efforts of our staff and volunteers for their precautionary work in May to re-locate Hospice House residents and safeguard Hospice assets in case the creek flooded. The Board also recognizes the support and cooperation of Interior Health Authority staff members who were responsible for ensuring our clients' care was maintained during this difficult period.

This year, the Board considered the Medical Assisted in Dying legislation (MAiD) to determine the Society's role in MAiD. After many months of discussion, research, interviews, and consultation the Board decided that MAID would not be performed at Hospice House but that Hospice would support the assessment procedures leading to MAID.

This year, the Society was supported with donations, grants, and special events that generated over \$600,000 which represents 30% of the total revenue required for our palliative care services each and every year. Without these funds, the Society could not achieve its vision and mission for the residents of the North Okanagan. The Board and the Society are extremely grateful for the generosity of donors and fund-raising which support the mission of the Society. Thank you on behalf of the clients of Hospice and the people served by the community programs and educational opportunities.

I would like to thank the directors who serve as volunteers on the board for your time, dedication to the Society, and your leadership that ensures the Society remains the valuable asset that it is.

As the new fiscal year begins, the Board will be seeking a long term relationship with Interior Health to achieve sustainable funding and to strive for a Society-to-Interior Health relationship that strengthens the role of Hospice and palliative care in the North Okanagan.

In closing thank you to all the staff, volunteers, donors and fundraisers for your continued support of Hospice House.

Financial Report 2017 - 2018



This year, our focus in the finance department was to implement the cost saving ideas and suggestions brought forward by management and staff last year. With the support of staff, volunteers and management, the implementation of these changes went very smoothly.



REVENUE NOTES

- NOHS is grateful for the ongoing financial support of the Province of BC which includes funding from Interior Health Authority, Ministry of Health and Community Gaming
 - RISK: Interior Health funding continues to fall short of the operating costs of Hospice House. NOHS continues to negotiate with IHA for sustainable core funding. RISK: Community Gaming Grants were reduced by \$24,000 for the 2018/19 period. NOHS must research other sources of funding to replace this previously stable source of funding for our volunteer and grief and bereavement programs.
- Approximately \$600,000 in annual fundraising is required to sustain our programs and services. Our two major fundraisers, Dancing with the Vernon Stars and the Journeys Campaign, continue to grow in success. We've introduced a new fundraiser to encourage monthly donors. We attribute the financial success of these fundraisers to ongoing community support through sponsorship, event participation and giftsin-kind.
 - RISK: Fundraising is increasingly competitive and expensive. In our relatively small catchment area, we compete with other worthy charities for limited charitable donations and event proceeds. Creativity in event management, focused attention on donor appreciation and evaluation of fundraising costs are tools used to mitigate this risk.
- We are so thankful to the kind and thoughtful members of our community who remember Hospice in their wills through bequests. RISK: Bequest amounts vary greatly from year to year and therefore only conservative amounts are budgeted for operational funding.
- Grant writing is an important component of revenue. RISK: Grants for ongoing programs are difficult to source. Grants are best suited for capital purchases or seed funding.
- Residents at Hospice House pay a daily fee as mandated by the Ministry of Health. This fee and other nominal fees for counselling services are ongoing sources of revenue for NOHS.

Operational Expenses (excluding amortization)

- Wages 76%
- Facility Costs 4%
- Organization Development & Administration 4%
- Program Expenses 8%
- Fundraising Event Expenses 6%

OPERATIONAL EXPENSE NOTES

- Paid staff members include: management, care staff, support staff and administrative/ finance staff.
- Care staff and support staff are members of the BC Nurses Union (BCNU). Our Collective Agreement with the BCNU is effective until June 2020.
- NOHS commits to a sustainable wage structure by conducting annual wage evaluations and comparisons.
- Approximately 76% of the Society's costs are staff wages.
- RISK: Given the proportion of wage costs to total costs, meaningful cost savings are achieved only through reductions to wages or staffing levels. Sustainable, core funding from government is required.

The North Okanagan Hospice Society (NOHS) advocates for all aspects of hospice, palliative care. NOHS supports education, research, and clinical care for those facing the end of their lives. Our staff and volunteers are dedicated and passionate as they serve the dying and those who love them.

Education: Our REACH program (Resources, Education,

and Advocacy to Champion Hospice palliative care) continues to grow and flourish. The REACH program is designed to engage, inform, and educate the public and professional care givers with the goal to improve palliative, end-of-life, and bereavement care. NOHS reaches out to the public and clinical staff through educational events such as community events, on-line webinars, professional development workshops, and in-house in-services.

Research: We are entering our second (2nd) year of partnership with the NavCare (Navigation, Connecting, Accessing, Resourcing, and Engaging) study. We have matched our specially trained hospice volunteers with older adults living in the community with a serious illness with the hope to improve quality-of-life. Early benefits of the study have indicated a reduction in social isolation, networking to resources, and facilitation of improved relations with families.

NavCare program: The experience of volunteering has changed my life completely. This is another program which demonstrates the need for volunteers. We have a very large number of people who require services and our systems are getting so complicated, most don't know which way to turn, to find what they are looking for. Every opportunity that arises, I take a moment to share my experiences with others, hoping that this will open up a door for them.

Clinical Care: Part of our work at NOHS is planning for the future and ensuring quality end-of-life care is available to all. Our student practicums for medical students, registered nurses, licensed practical nurses and health care aids provide an opportunity for students to learn the type of skilled and compassionate care necessary to ensure quality care.

As I write this, my time is coming to close as I retire from my position as the Learning and Effectiveness Leader. It has been an honour and a privilege to work in such an incredible, compassionate and caring environment with staff and volunteers who strive for excellence in the care that is provided and received.


